#### From the Executive Director

Successful communities are often the result of good folks who step up and commit their time, ideas and resources to the common good. The High Country and Blue Ridge Conservancy are fortunate to have two such people in John and Faye Cooper.

Faye and John became directly involved with Blue Ridge Conservancy in 2004 with the donation of a conservation easement on 21.7 acres of beautiful farmland adjacent to the original Mast General store in Valle Crucis. They placed an additional 8 acres under easement in 2010 resulting in almost 30 protected acres. The property represents some of the best farmland in Watauga County. In late 2015, the Coopers donated

the ownership of the originally protected 21.7 acres to Blue Ridge Conservancy. Their wish is for the Conservancy to use the property to enhance environmental stewardship, education and sustainable agriculture.

Faye and John live by the motto "it is better to give than to receive." The Coopers purchased the original Mast General Store in Valle Crucis in 1979. Today, in addition to the original store and annex, there are eight stores in North Carolina, Tennessee and South Carolina. The Cooper's generosity to the High Country has grown in lockstep with the success of Mast General.

The Coopers began their involvement with land conservation in 1985. Just five years after purchasing the original Mast General Store they became actively involved with a committed group of citizens to stop a development project that would have permanently changed the rural character of Valle Crucis. In 1990, again with leadership from the Coopers, Valle Crucis became the state's first rural historic district adding a layer of protection for the community's rural character and cultural heritage. In 2008, the original Mast Store was added to the National Register of Historic Places.

John and Faye were also leaders in establishing the Valle Crucis Community Park. The park is a popular destination, offering a beautiful setting to walk, jog, picnic, play, fish, swim and socialize along the banks of the Watauga River. The Coopers continue to be active in the park's support, development and expansion.

Under the Cooper's guidance, Mast General Store has become a leader in Land Trust Day. Now in its 14th year, Land Trust Day is held in conjunction with National Trails Day, which honors the important role that protected natural environments and the outdoors play in the health and economy of communities across the United States. Mast General Store donates a whopping 20% of its sales on Land Trust Day to Blue Ridge Conservancy and other local land trusts adding tens of thousands of dollars annually to support conservation. This year, Land Trust Day falls on Saturday, June 4th.

John has served on Blue Ridge Conservancy's Board of Directors for over three years. Additionally, he is leading the effort to save and restore the Appalachian Theatre in Boone.

John and Faye sum up their belief in community engagement by saying. "We believe that those of us who live in the Blue Ridge Mountains are provided many opportunities to serve others, and by doing so, we have changed and improved our communities and ultimately enriched our own lives."

### **VOLUNTEERS** of the year

Blue Ridge Conservancy was built on the energy and efforts of volunteers. As the roots of BRC, volunteers remain an essential part of the work we do to save the places you love. This year, we are excited to present this award to two very outstanding volunteers.



#### Edgar Peck

A small group of passionate paddlers took an ambitious dream and made it reality. Their determination, organization, and patience created a unique opportunity for BRC to purchase a 2.3-acre river access area on the Watauga River at Guy Ford Road in Sugar Grove.

Edgar led the charge organizing and rallying the boating community and other river lovers to raise the money towards purchasing the property. His efforts resulted in 140 private donors along with funding from the Watauga County Tourism Development Authority and the Tennessee Valley Authority.

In addition to paddling, this property will provide river access for fishing, swimming, picnicking, and other activities for residents and visitors alike, aligning with BRC's mission to protect places with recreational value.

"If we want to continue to enjoy these experiences, the preservation of beautiful, wild, untamed, natural areas like the Watauga River Basin must be a priority, not just in our thoughts, but in our actions," said Peck.

Edgar is the Physical Education Activity Director at Appalachian State University. He teaches a variety of physical education classes from kayaking to badminton.



#### Elizabeth Hempfling

Elizabeth Hempfling, a Boone native and professional event planner, has volunteered her time and talent to organize BRC's annual Gamekeeper Wine/Beer Tasting and Auction hosted at Camp Sky Ranch.

The Wine/Beer Tasting and Auction has become a favorite local event amongst the High Country community and continues to be a successful fundraiser thanks to Elizabeth's expertise. In 2015 the event raised over \$24,000 in donations.

"I guess it just comes naturally that I hold a fondness in my heart for the mountains. For the past 5 years our team has had the pleasure of working along side of Blue Ridge Conservancy and their amazing staff on their annual wine/ beer tasting and auction. It is always so rewarding to see the community come together to raise money for such a good cause. # Land Protection & Stewardship Highlights



#### **Camp Lutherock**

Located on the southwestern slope of Sugar Mountain in Avery County, Camp Lutherock is now permanently protected after a decade long collaborative effort between BRC, the NC Clean Water Management Trust Fund, and NovusWay Ministries.

The property is an important part of the view from many nearby mountains including Grandfather, Beech, Roan, Table Rock, and Hawksbill. It is also visible from the distant Black Mountains including Mt. Mitchell, the highest peak in the Eastern U.S. Skiers and snowboarders at Sugar Mountain Resort enjoy views of the Camp Lutherock from the North Ridge ski slope. The protected property also shares a quarter-mile boundary with the Linville Ridge Community.

It is considered a Significant Natural Area by the NC Natural Heritage Program due to its unique ecological character. The camp hosts two endangered ecosystems, three endangered species, and numerous other rare species and high quality forests. It also contains headwater streams for the North Toe River and Sugar Creek, which provide excellent water resources and rich habitats for aquatic life.

Camp Lutherock uses the land for recreation including hiking, an advanced high ropes course, rock climbing, disc golf, and other camp activities, meetings, and conferences. The camp serves people of all ages from throughout the Southeastern United States with primarily outdoor adventure oriented camping.

The project was funded by a grant awarded by Clean Water Management Trust Fund and a generous donation from Fred and Alice Stanback.

#### Valle Crucis Historic Farmland

BRC received a generous donation of 21.7 acres of farmland located within the Valle Crucis Historic District along NC Highway 194, one of our state's Scenic Byways. Thanks to the generosity of John and Faye Cooper, longtime residents, conservationists and owners of Mast General Store, this beautiful property will forever remain as agricultural and recreational land along Dutch Creek and the Watauga River.

The land is considered "Prime Farmland" by the United States Department of Agriculture. There are two existing barns on the property that will be preserved as contributing to the scenic and cultural heritage. The land borders the Watauga River for 500 feet. This section of the Watauga is designated High Quality Waters by the NC Division of



Water Resources and Delayed Harvest trout waters by the NC Wildlife Resources Commission. The Watauga River is also designated by the NC Natural Heritage Program (NHP) as regionally significant Aquatic Habitat.

The conserved land, rich in history and scenic beauty, is adjacent to the original Mast General Store and the Valle Crucis Community Park. With the proximity of the property to the center of the Valle Crucis Community, BRC hopes to use the land as a showpiece of sustainable agriculture and environmental stewardship. Potential long term objectives include hosting educational workshops, agricultural demonstrations, stream restoration on Dutch Creek and the Watauga River, and expanding the trails in the Valle Crucis Community Park.

The Conservation Trust for North Carolina (CTNC) holds a conservation easement on the property ensuring it will remain in agricultural and recreational use forever.

#### Watauga River Access at Guy Ford Road

Through strategic partnerships and community support, BRC purchased a 2.3 acre river access area on the Watauga River at Guy Ford Road in Sugar Grove. The property is located between two existing river access sites; one known as Watauga Gorge Park, owned by Watauga County, and the other at Tester Road, owned by American Whitewater, a non-profit organization conserving and restoring America's whitewater resources.

The Guy Ford River Access is part of the 21 mile Watauga River Paddle Trail, which traverses through Valle Crucis, a National Rural Historic District, and continues into Tennessee. Local businesses, tourists and citizens currently use Guy Ford Road as a river access point. The property will be enrolled in the Public Fishing Access Program managed by the NC Wildlife Resources Commission.

Financial support for the acquisition came from the Watauga County Tourism Development Authority, Tennessee Valley Authority and 140 private donors.

The river access site will serve as a put-in for the Watauga Gorge with class IV-V rapids, as well as a take out for Section III, consisting of class II-III rapids beginning at the Upper Gorge Park. These sections of river draw paddlers from all over the Southeast. In addition, this property will provide river access for fishing, swimming, picnicking, and other activities for residents and visitors alike.

The local community and dedicated organizations will manage the access point for the benefit of tourist based river activities and community members. Future plans for the access point include parking, signage, information kiosks, and support facilities as outlined in the Watauga County Recreation Plan.



#### **Peak Mountain**

This ridgetop property consists of 245 acres located on Peak Mountain in Watauga and Avery counties. The property is highly visible from Seven Devils, the NC Hwy 105 corridor, Grandfather Mountain, Hanging Rock and other mountains and ridges in the vicinity. The land lies within the Dun Vegan Mountain Natural Area as designated by the NC Natural Heritage Program (NHP). Its conservation value is enhanced by close proximity to Grandfather Mountain and Bear Paw State Natural Area.

Peak Mountain includes a well-defined ridgeline running from SW to NE through the center of the property. Much of the northern portion of the land adjoins Hawksnest Resort.

Valley Creek, a tributary of the Watauga River, flows along the NE portion of the boundary and is designated Trout Waters by the NC Division of Water Resources.

Acquisition of Peak Mountain was possible from a generous donation by Fred and Alice Stanback.



#### Phillips Property on Pond Mountain

BRC continued to expand the Pond Mountain Game Lands in Ashe County with the addition of the 97 acre Phillips tract. The property contains the headwaters of Big Horse Creek as well as two seep areas along the north facing slope. Funding for the project included resources from the NC Clean Water Management Trust Fund and a private gift from Fred and Alice Stanback.



With the addition of the Phillips tract, BRC has protected 2,900 acres for the Pond Mountain Game Lands.

#### Foscoe Bog

Mountain bogs that once dotted the landscape have become a rare sight. That is why BRC jumped at the opportunity to accept a donation of a bog along the Watauga River. Located off of Hwy 105 this 10 acre property is a local hotspot for bird watching by local Audubon members and will provide a location for future research and study. The property was generously donated by a local attorney Eric Eller and the heirs of Ronald Murrelle. Mr. Murrelle always wanted to see the property protected for its ecological value and his son and daughter were happy to work with BRC to make his dream a reality.

Blue Ridge Conservancy is pleased to welcome Wendy Patoprsty to the team as the new, fulltime Project Director for the Middle Fork Greenway.


Wendy moved to Watauga County in 2000 after receiving a Bachelor of Science in Horticulture from the University of Georgia. She started with Watauga County Cooperative Extension in 2001 as a grant funded Water Quality Technician and was hired as a Natural Resource Extension Agent in 2003. In this position Wendy collaborated in community development projects including stream restoration, urban stormwater projects and community environmental education. In 2014 Wendy received her Master's degree in Geography from Appalachian State University.

"Being a part of Blue Ridge Conservancy is a dream come true for me," said Patoprsty. "I am grateful for my 15 years of service working as the Natural Resource Extension Agent in Watauga and Avery counties as it gave me a great foundation for community development and environmental stewardship. I am thrilled to work with the Middle Fork Greenway team to establish the greenway trail linking the Boone and Blowing Rock communities. I believe this project is another step towards improving the quality of life for the residents and visitors of the High Country. It is so exciting to visualize riding a bike safely down the US Hwy 321 corridor while getting to experience the beauty of our mountain headwater streams."

The Middle Fork Greenway (MFG) is a pedestrian and cycling greenway trail along the Middle Fork of the New River and US Hwy 321 corridor connecting Boone and Blowing Rock. Development of the greenway is being led by Blue Ridge Conservancy and High Country Pathways, in partnership with local governments and many community partners.

#### **New Partnerships**

Recent contributions by three organizations are wonderful examples of the private/public partnerships that are making the MFG a reality.

A \$168,750 donation by Blue Cross Blue Shield of North Carolina (BCBSNC) to BRC provided matching funds to leverage a grant for \$196,192 from the NC Clean Water Management Trust Fund (CWMTF). The combined funds will be used to purchase a 12 acres tract enabling a two-thirds mile extension of the existing greenway. The extension will connect two pocket parks along the Middle Fork of the New River. With its wide buffer hosting rhododendron and other native plants, MFG leaders believe this segment will be particularly beautiful. Once the trail is constructed, almost two miles of the 6.5 mile greenway will be complete. Funding for building this new section is being pursued.

Other current priorities for the MFG include securing funding to complete construction on the Chestnut Ridge and National Park Service properties near Blowing Rock and advancing the Boone section through the new Wellness District to connect the Boone Greenway.

MFG also received \$10,000 from the PeopleForBikes, an organization based in Boulder, Colorado that provides resources to help create safe and convenient biking communities across the country. PeopleForBikes has funded more than 300 projects since 1999, including bike lanes, paths, parks, and advocacy programs.

#### **Sterling Creek Park Dedication**

Last September, Sterling Creek, one of three pocket parks along the route of the Middle Fork Greenway, had a dedication party. One of the highlights of the celebration was a Seisin Ceremony, a ritual dating back to the days of freehold estates in which the grantors of the property present the grantees with a clump of dirt and in return, the grantees receive a basket of leaves and twigs. Barbara and Sterling Whitener presented a cup of earth from the park to Eric Hiegl, BRC's Land Protection and Stewardship Director. In exchange, Eric presented the Whiteners with a basket of leaves, sealing the transaction.

In 2005 Sterling and Barbara Whitener and Donald and Elizabeth Whitener donated 3.6 acres along the west side of the Middle Fork to BRC. The gift was made with the

intent that the land be preserved and protected forever for its natural beauty with the exception of the development of a greenway and small park. The result is beautiful Sterling Creek Park.

#### **Informing the Public**

Last November, an open forum was held in Blowing Rock to educate the public about the Middle Fork Greenway. The forum, held at the newly renovated American Legion Building, attracted over 70 people despite unfavorable weather conditions.

Several survey questions were posted to attendees including, "Do you think the MFG is a good initiative for our region?" and "How will you use the greenway?" Results of the survey can be obtained from Wendy Patoprsty, Director of the Middle Fork Greenway.

# Engaging Millennials







Raising awareness about conservation and its impact on future generations is an issue addressed by land trusts across the country. The goal is to reach and engage a younger and more diverse audience by creating experiences relevant to them and their circles of influence. Over the last year, BRC was fortunate to work with three service oriented groups of young conservationists and community organizers.

"Make a Difference Day" is an annual event that brings AmeriCorps Project Conserve members together to complete a service project in Western North Carolina. Last October, Project Conserve members joined BRC staff to help restore an important pastoral property visible from the Valle Crucis Historic District. The volunteer work included cutting and removing white pine, invasive multiflora rose, and locust saplings from the field. Earlier this year, the BRC Student Club and Appalachian and Community Together (both Appalachian State University organizations), picked up where the AmeriCorps team left off and continued the field restoration process.

BRC is grateful for our volunteers and for the opportunity to engage future conservationists.



## The Farm Incubator and Grower Project



The Farm Incubator and Grower (FIG) farm provides land, production and marketing infrastructure to beginning farmers in the hopes of establishing lasting agricultural enterprises in the High Country. The farm is located on property owned by the Valle Crucis Conference Center and the land is protected by a conservation easement.

Protecting land for agricultural purposes is a significant part of BRC's mission. As part of our mission and in our efforts to support sustainable agriculture, BRC is working with Watauga River Partners, the NC Clean Water Management Trust Fund, Bare Essentials Natural Market in Boone, the High Country Chapter of Trout Unlimited and volunteers through ASU to maintain a healthy riparian corridor along Dutch Creek which flows through the FIG farm.

This spring a team of volunteers removed invasive species, including multiflora rose, garlic mustard, Japanese knotweed, replacing them with native plants. The new plantings included elderberry, nine bark, silky dogwood, and silky willow.




